WildFF provided support in grant writing, business development and funding.

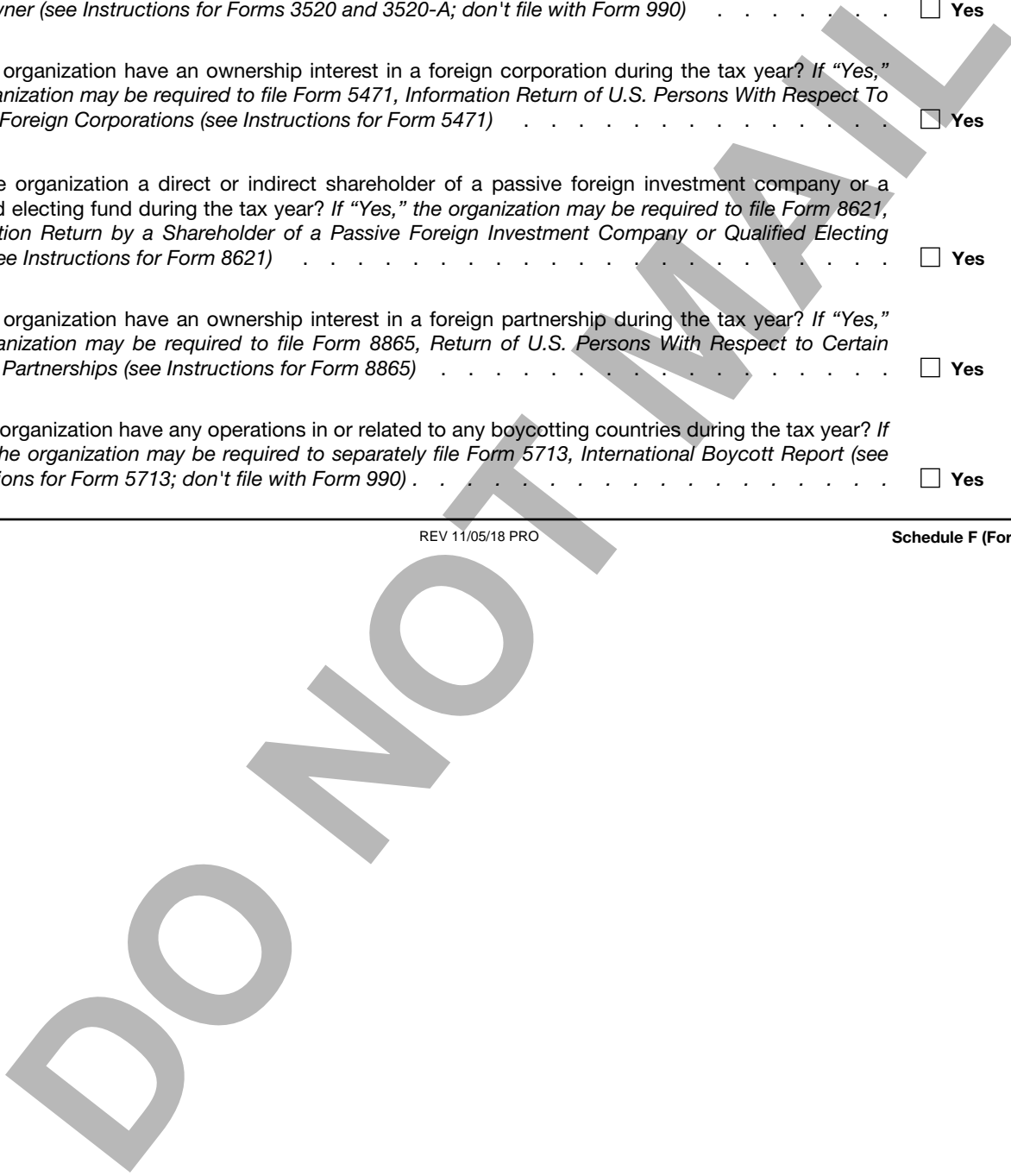

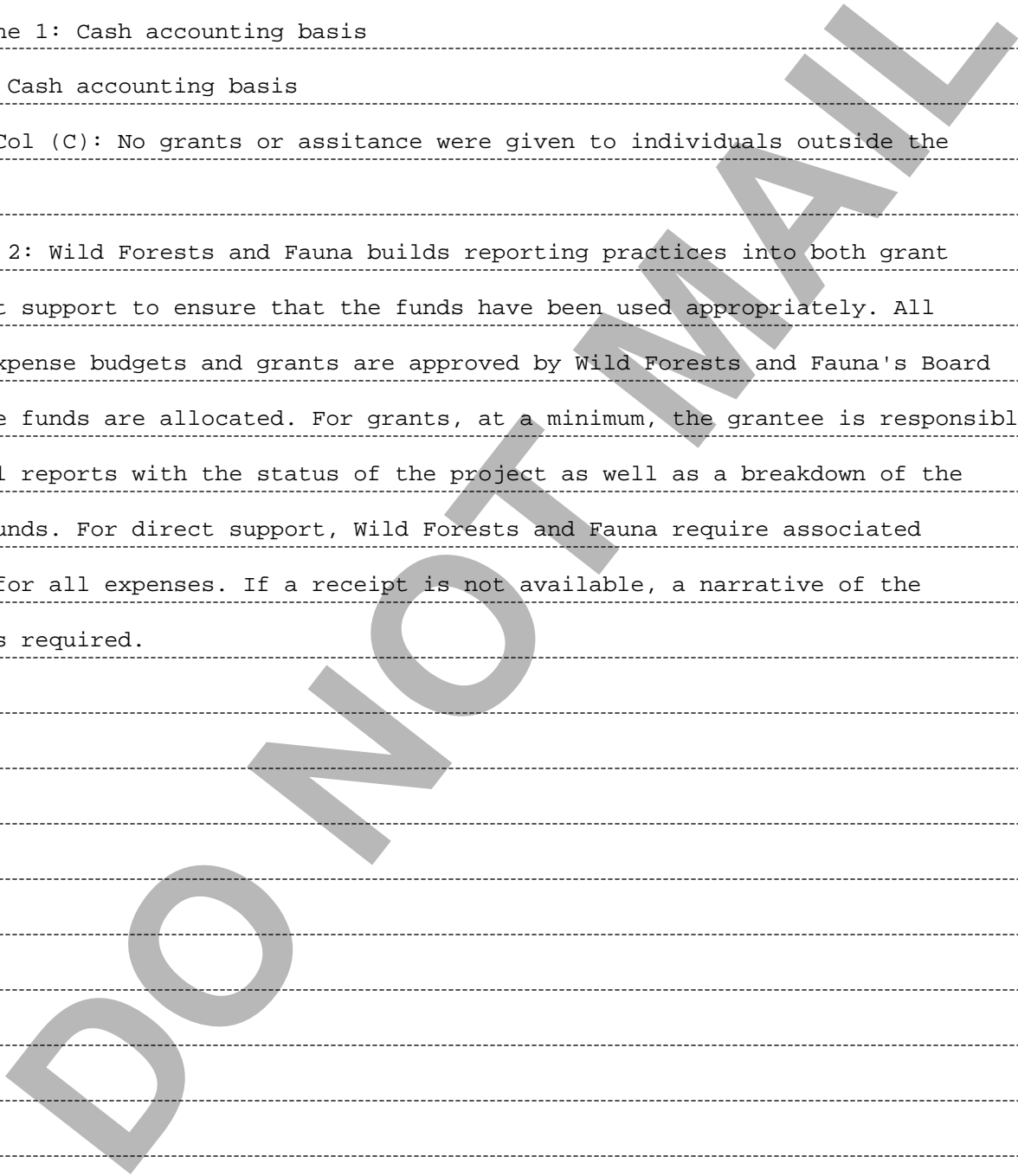
